The Initial Selection Round will be judged using DVDs (in

DVD-video format) of applicants' performances.

The Preliminary Rounds and the Final will be open to the public.

Judging 1. The results of the Initial Selections will be publically

announced on the competition website.

2. All contestants' results will be made public.

3. The jurors will have no contact with the contestants between Round 1 and the Final. This rule does not apply to any contestants who have been eliminated from the competition at

an earlier stage.

4. The Jury's decision is final. Neither appeals nor objections will

be accepted.

# Application

\*Application shall be sent by registered mail within Japan and by Express Mail Service from overseas.

# [1] How to apply online

Enter required information in the Entry Sheet on the official website (http://www.tipc.jp) and upload the following data (1-3).

- A DVD recording (in DVD-video format) of the applicant performing the set pieces.
  - \*A DVD recorded in DVD-video format shall be compressed and uploaded to the VIDEO\_TS folder.
- One color photograph taken within 6 months of the application date. (Upper body/Resolution of 300 dpi or more is recommended.)
  - \*The photo will be used for the official competition program and other media purposes.
- 3. A PDF or JPG file of an official document, such as a passport, as evidence of the applicant's name, nationality, and age.
  - \*Please see the official website for how to prepare the entry sheet.
  - \*The entered data can be edited during the application period (1 April 2017-20 September 2017).

# [2] How to apply by post

Applicants shall send the following documents and a DVD to the TIPC Office by 20th September 2017.

- 1. Application.
  - \*Available for download from the official website. (http://www.tipc.jp) (PDF, others)
- 2. A DVD recording of the applicant performing the set pieces.
  - \*The DVD shall be in DVD-video format. "Recording of the performance" shall be observed
- 3. Two color photographs taken within 6 months of the application date. (\* 4 × 5 cm/ Upper body / Resolution of 300 dpi or more recommended / your name and the date of recording shall be written on the backside.)
  - \*Prepare two identical photographs, one to be affixed to the application form and one to be used for publicity materials, such as the program.
- An official document or its copy, such as a passport, as evidence of the applicant's name, nationality, and age.

#### Remark

- Only applications which are postmarked no later than the due date will be accepted.
- Applications with insufficient or incomplete responses will not be reviewed by the Preliminary Judges.
- Online applicants should contact the Office if an email confirming application is not received within one week of application. Postal applicants should contact the Office if an email confirming application is not received within ten days of the postal date.
- Applications must correctly contain the name of the composer, the name
  of the piece of music, the key, the opus number, the movement and other
  necessary information regarding the piece of music selected.
- · Documents, DVDs, etc. submitted for application will not be returned.



# **Initial Selection**

The Initial Selection will be conducted on the basis of the documents submitted by the applicants and a DVD recording (in DVD-video format) of the applicants performing the set pieces.

# Repertoire for the Initial Selections

Applicants should select two pieces, one from group (A) and one from group (B) listed below, record them onto a DVD, and send them to the Competition Office.

- (A) CHOPIN: one piece from either Etude Op. 10 or Op. 25
- (B) LISZT, SCRIABIN, RACHMANINOV, DEBUSSY, STRAVINSKY or PROKOFIEV: one piece from Etudes

# Recording of the Performance

- The performances should have been recorded after the 1st October 2016.
- The camera shall be fixed and the face and hands of the performer shall be visible at the same time.
- One piece shall be recorded without stopping the camera. When sending the CD by post, two pieces shall be recorded in one DVD-R.
- · Any DVDs with editing shall not be included in the initial selections.
- Any DVDs with recordings other than the set pieces shall not be included in the initial selections.
- Computers will be used to view DVDs. Where possible, use a computer to record onto a DVD. When using a DVD recorder, the DVD must be finalized. Before sending a DVD, confirm it can be viewed on a computer.
- Applicants shall clearly write their name, the name of the piece
  of music, the date it was recorded and the place of the
  performance on the DVD. When (A) and (B) have different
  performance dates and/or places of performance, their respective
  date and place of performance shall be clearly indicated.
- Online applicants shall upload a compressed file to the VIDEO\_TS folder.

# Notification of Initial Selection Results

The results of the Initial Selections will be sent to all applicants individually by Tuesday, 5th December 2017.

\*Applicants who are successful in the Initial Selections will be sent information about the competition and a Consent Form for Competition Entry as well as the score of the commissioned piece.

<sup>\*</sup>Recorded media received that is not DVD-R will not be accepted.

<sup>\*</sup>The DVD system in Japan is NTSC.

<sup>\*</sup>The DVD-video format standard was established by DVD Forum as those able to be viewed on regular DVD players and computers. When this format is used, files show on the computer as containing the folders VIDEO\_TS and AUDIO\_TS. The VIDEO\_TS folder contains the files \*\*\*.IFO and \*\*\*.VOB.

<sup>\*</sup>The preliminary judging is the beginning of the judging process. Please record the performance with the same preparedness as the actual performance.



# Repertoire

The competition consists of Preliminary Rounds (Round 1-3) and a Final.

Judging will be based on the contestants' performances of their selection from the set pieces.

#### Round 1

Contestants play the following pieces in the order of (A), (B), and (C). The performance time shall be between 20 minutes and 25 minutes in total. The repetition shall be at one's discretion.

- (A) J. S. BACH: one piece from "The Well-Tempered Clavier", vol. I or vol. II
- (B) F. CHOPIN: one piece from either Etude Op. 10 or Op. 25 \*Contestants may play the same piece that they performed during the Initial Selections.
- (C) One piece composed after 1900

\*Contestants may NOT play the same piece that they performed during the Initial Selections.

#### Round 2

Contestants will be required to play the following pieces in the order of **(A)** and **(B)**. The performance time shall be no more than 45 minutes in total.

- (A) HAYDN, MOZART, or BEETHOVEN: all the movements of a sonata
- (B) Piece(s) of your choice by SCHUMANN, BRAHMS, SCHUBERT, MENDELSSOHN, CHOPIN, or LISZT
  - \*You may choose pieces by multiple composers.
  - \*In the case of a sonata, you must play all of its movements.

#### Round 3

Contestants play the following pieces in the order of (A), (B), and (C).

- (A) W. A. MOZART: one variation of your choice from the list below. The repetition shall be at one's discretion.
  - 6 Variations in F major on the aria "Salve tu, Domine" from the opera "I filosofi immaginari" by Giovanni Paisiello, K. 398
  - 10 Variations in G major on the aria "Unser dummer Pöbel meint" from "La rencontre imprévue" by Christoph Willibald Gluck, K. 455
  - 12 Variations on an Allegretto in B flat major, K. 500
  - 9 Variations in D major on a Menuet by Jean-Pierre Duport, K. 573
- (B) A piece commissioned for this competition (about 5 minutes in length)

- (C) Contestants will select one of the piano quartets listed below and play with the string players specified by the Office. Use the scores of Henle edition for SCHUMANN and BRAHMS and the score of International Music edition for FAURE. The repetition will be played.
  - R. SCHUMANN: Piano Quartet in E flat major, Op. 47
  - J. BRAHMS: Piano Quartet No. 1 in G minor, Op. 25
  - · G. FAURE: Piano Quartet No. 1 in C minor, Op. 15

#### Notes on Performances

- 1) All performances shall be done by memory except for the commissioned piece and the piano quartet in Round 3.
- 2) All performances will be open to the general public.
- 3) A part of your performance piece may be cut because of time

## Order of Performance

- 1) The performance order for contestants will be determined by lottery during the Contestant Orientation. The Chair of the Music Committee will draw lots at random.
- 2) Contestants who cannot perform in the order specified will be disqualified.
- 3) The order may be changed for the Final only, for the convenience of the program.

#### Piano Selection

- 1) Contestants may play all pianos specified by the TIPC Office in order to select the piano.
- 2) Contestants are permitted to change their choice of piano for the following round and for the final within one hour of the results of the previous round being announced. However, trying out the pianos will not be possible.

# Practice Pianos

The following opportunities for practice will be provided to contestants free of charge during the competition. The practice time will be as follows.

- 1) If contestants wish to practice on the day of registration, the TIPC Office will make every effort to prepare a room but it might not be possible depending on the venue.
- 2) Four-hour practice slots per day in a room equipped with a piano from the day of Orientation. Four hours or more after Round 2, depending on the venue.
- 3) Contestants will have one practice with the string players before Round 3, which will be within 90 minutes, in principle. Contestants will have a dress rehearsal before the performance.
- 4) Finalists will be able to practice on a piano in a room designated by the Office from the day after the day of Round 3 until the final day of the performances in scheduled time slots.
- 5) Contestants will have one practice with the orchestra for the Final, which will be within 90 minutes in principle (including the discussion with the conductor).

#### Registration of Contestants

Contestants will register before the contestant orientation notified by the TIPC Office and attendance to the contestant orientation will complete the registration. This rule does not apply when the Chair of Jury allows that the circumstances are inevitable.

## Financial Support for Transportation Cost

Contestants will bear the travel expenses in principle. If applicable, however, the amount specified by the organizer will be provided.

# [Contestants who reside overseas]

JPY 50,000 for those who currently reside in Asia (specified by Foreign Ministry).

JPY 100,000 for those residing in an area other than the above.

[Contestants who reside in Japan but currently study abroad] Half of the amount above.

# [Contestants who reside in Japan]

Contestants who reside in Japan are not subject to financial support for transportation costs.

# Financial Support for Accommodation Costs

Accommodation will be provided to the contestants from three days prior to the start of the competition (11 March, 2018) to the dates below. The accommodation cost will be borne by the TIPC Office only for the accommodation designated by the TIPC Office. All other expenses occurred during the period of stay, including meals, communications, etc., will be covered by the contestants

- . Contestants in Round 1: Until the morning after the end of the 1st Round.
- . Contestants in Round 2: Until the morning after the end of the 2nd Round.
- . Contestants in Round 3: Until the morning after the end of the 3rd Round.
- . Contestants in the Final Round : Until the morning of the second day after the end of the Final Round.
- \*Contestants will be introduced to local families if they indicate the desire to participate in a homestay program after the TIPC is finished.



## Others

#### Visa

Contestants who are required to obtain a visa to enter Japan are responsible for applying for it.

If an invitation letter is needed for acquiring the visa, please apply for it to the TIPC Office when submitting the Consent Form.

#### Insurance

Contestants shall purchase insurance for his/her health, accident, fire, theft and damage to luggage and personal belongings for the term from when you leave your country until you return to your country, if necessary.

# Neighboring Rights

All rights for broadcasting, performing, audio and visual recording, publishing, photographing, etc., of performances for all TIPC rounds, the opening ceremony and awards ceremony and any related performances held after the conclusion of the TIPC will belong to the Organizer.

# Protection of Personal Information
